### **Business Expansion Plan**

Hooves & Paws Rescue, Inc. is in the process of expanding our current Rescue/Shelter. We would like to share with everyone what our plans are in hopes that we can get your support to make this expansion a reality.

## **Overview and Objectives:**

### **Mission Statement**

At Hooves & Paws Rescue, Inc. we rehabilitate abused, starved, neglected or unwanted horses, dogs and soon a limited number of cats. If possible, following rehabilitation, we place such animals in loving homes. If for any reason an animal cannot be placed, the animal will live its life out at our facility in a safe, loving environment.

### **Objectives**

Our intention at Hooves & Paws Rescue, Inc. is to expand our current operations. This will allow for expanded service to include all size dogs, horses, donkeys, mules and a limited number of cats. **Hooves & Paws Rescue, Inc. will continue their mission as a "NO-KILL" shelter.**

### **Plan**

Hooves & Paws Rescue, Inc. will eventually hire a full-time animal control officer. Veterinary services will be provided as needed off-site. The remainder of the staff will be volunteer based with the exception of Genea Stoops, President & Bill Stoops Vice-President of Hooves & Paws Rescue, Inc. **Neither Genea nor Bill Stoops will take any salary for their roles as President & Vice-President of the facility until it is 100% functional and funded,** at that time a small salary will be split between both Owners. Since Hooves & Paws Rescue, Inc. opened their doors in 2006 there have been **no paid employees.** **All Volunteers, Board of Directors, and Owners have donated 100% of the time and effort required to successfully manage, operate, and support the rescue's efforts.**

As of September 15, 2006 Hooves & Paws Rescue, Inc. was awarded 501(c)(3) tax-exempt status. All Donations from September 15, 2006 forward are tax deductible as allowed by law.

## Financing Needs

Hooves & Paws Rescue, Inc. expansion will include a steel building to house and care for small animals. The Facility will be a 50 x 50 Steel Building that will include (10) inside dog kennels that can be divided into two if needed and (5) inside cat kennels that can also be divided into two if needed. Additionally, there will be outside runs for the dogs so that they have access to going outside at will. The Small Animal Facility will include a reception area, a small animal adoption- greeting area, and office area for staff and volunteers. We estimate that the Steel Building, Contents, AC/Heating, Plumbing and Drive Way cost will be \$120,000.00 minimum. **We are accepting In-Kind donations for the Steel Building, Contents, AC/Heating, Plumbing and Drive Way.**

Our goal is to break ground on the new facility as soon as the funds are raised through grants and/or donations. We anticipate groundbreaking will begin early Spring 2012. This new Facility will be located at our current facility at 27821 US Hwy in Glenwood, IA.

## Experience, Capabilities, Business Resources

Bill and Genea Stoops, Owners of Hooves & Paws Rescue, Inc. have owned and operated their current Rescue/Shelter facility since 2005 using their own funds to open the Non-Profit facility to the public in September of 2006. Hooves & Paws Rescue, Inc. has successfully rehabilitated several hundreds of dogs and of horses who have been allowed the *time* to heal enough to be placed in forever homes. Additionally, Hooves & Paws Rescue, Inc. has an extensive network of dog, cat, and horse foster homes throughout the heartland and across the United States.

On a regular basis Hooves & Paws Rescue, Inc. is called on by local law enforcement in many areas that include, but are not limited to, the Sheriff's Department, local Police Departments and the State Highway Patrol. Hooves & Paws Rescue, Inc. will continue its close working relationships with local law enforcement as they are called upon.

Hooves & Paws Rescue, Inc. has an outstanding record of accomplishment rescuing and rehabilitating abused animals. Hooves & Paws Rescue, Inc. has and will continue to offer training and education to the public on the proper care and treatment of animals. Also, we will continue our practice of working with local law enforcement to remove animals from abusive situations and will continue to answer calls for help with capture and containment of animals found wandering loose whether they are dogs, cats, horses and other hoofed animals. Hooves & Paws Rescue, Inc. will continue to request funding through grant writing campaigns, local fundraising events, and continued website donation support.

## Fund Raising Events

Hooves & Paws Rescue, Inc. has many fund raising events throughout the year for the animals and our hope is that we can host many more events for the animals that need a place to call home until adoption is possible.
